

# **Audit Performance Statistics**

We've committed to being open about our audit inspection performance scoring across our contractors and ICPs. Below shows our year to date scores for 2018-19 where the average number of non-conformities identified in inspections, is represented alongside number of audits. We have decided to continue this action from last year, having listened to your feedback that said you found this information useful.



**Q2 inspection data** shows very low non compliance reports being submitted compared to the number of Audits completed, showing that we are all working hard to make sure we get it right first time.
